

Mark Herrmann graduated from Princeton University in 1979 and The University of Michigan Law School (Order of the Coif, Michigan Law Review) in 1983. After graduation, he clerked for The Honorable Dorothy W. Nelson in the United States Court of Appeals for the Ninth Circuit. Mark practiced at Steinhart & Falconer in San Francisco from 1984 to 1989, when he moved to Cleveland and joined the international law firm Jones Day, where he is now a partner.

Mark Herrmann tells the unvarnished truth about what it takes to succeed in the practice of law. He doesn't say it's easy, but he tells you what partners really care about and how to impress them and

to progress in a firm. His suggestions also apply to how any lawyer can impress a judge. I give this book to any new lawyer that I swear in and tell them that the keys to success are contained in its pages.

The headline here pretty much says it all. The only reason I didn't give this book five stars is that it's oriented more towards "big law" and the practice of civil law. That made it a little bit less interesting to me. Still, the book is well-written, and humorous, and contains some really good advice, particularly when it comes to the issue of persuading, and writing. I would definitely recommend this book, especially if you're a "young" (i.e., new) lawyer, plan to become one, or just have an interest in knowing what people in such a position need to know.
