

Churchill, Roosevelt & Company: Studies In Character And Statecraft



Synopsis

During World War II the “special relationship” between the United States and Great Britain cemented the alliance that won the war in the West. But the ultimate victory of that partnership has obscured many of the conflicts behind Franklin Roosevelt’s charm and Winston Churchill’s victory signs—the clashes of principles and especially personalities between and within the leadership of the two nations. Synthesizing an impressive variety of sources from memoirs and letters to histories and biographies, Lewis E. Lehrman explains how the Anglo-American alliance worked—and occasionally did not work—by presenting portraits and case studies of the men who worked the back channels and back rooms, the generals and the admirals, the secretaries and under secretaries, ambassadors and ministers, responsible for carrying out Roosevelt’s and Churchill’s agendas while also pursuing their own. Such was the conduct of Joseph Kennedy, American ambassador to England often at odds with FDR; generals George C. Marshall and Dwight D. Eisenhower; spymasters William Donovan and William Stephenson; Secretary of State Cordell Hull, whom FDR frequently bypassed in favor of Under Secretary Sumner Welles; the Soviet spy in the leadership cadre of the US Treasury, Harry Dexter White, and his struggle with Lord Keynes; British ambassadors Lord Lothian and Lord Halifax; and, above them all, Roosevelt and Churchill. The President and the Prime Minister had the difficult task, not always well-performed, of managing their subordinates. Churchill and Roosevelt frequently chose to conduct foreign policy directly between themselves, and with Stalin. Scrupulous in its research and fair in its judgments, Lehrman’s book reveals the personal diplomacy, the character and statecraft, at the core of the leadership of the Anglo-American alliance.

Lewis E. Lehrman was presented the National Humanities Medal at the White House for his work in American history. Lehrman has written for the Washington Post, New York Times, Wall Street Journal, The Finest Hour, National Review, New York Sun, Harper's, The Churchill Project at Hillsdale College, and The Chartwell Bulletin. Lehrman authored Lincoln at Peoria: The Turning Point (a history of Mr. Lincoln's anti-slavery campaign from 1854 to 1865); Lincoln by littles (a book of essays about President Lincoln); and, Money, Gold, and

History (essays analyzing the modern history of money and its role in civilization), among other books. Lewis E. Lehrman and Richard Gilder established the Gilder Lehrman Center for the Study of Slavery, Resistance and Abolition at Yale University. Together Lehrman and Gilder developed the unique Gilder Lehrman Collection of original historical manuscripts and documents to teach American history from primary sources. Lehrman received a B.A. from Yale and an M.A. in history from Harvard. He was a Carnegie Teaching Fellow in History at Yale and a Woodrow Wilson Fellow in History at Harvard. He has been awarded Honorary Degrees from Babson College, Gettysburg College, Lincoln College, Marymount University, and Thomas Aquinas College.

I found especially poignant the portrait of Harry Hopkins, who so ably facilitated the FDR-Churchill relationship, and the way that that crucial relationship grew and then (sadly) deteriorated. The chapters on Assistant Treasury Secretary Harry Dexter White and the Bretton Woods accord are most illuminating, partly because of the authorÃ¢â€šâ€œs deep understanding of international finance and monetary policy, and partly because he shows in detail how WhiteÃ¢â€šâ€œs spying for the Soviets damaged American interests. Lehrman avails himself of the meticulous and revelatory scholarship on the Communist Party USA by Harvey Klehr and John Earl Haynes, whose books on that subject are among this generationÃ¢â€šâ€œs most important contributions to the understanding of modern American history.

Churchill, Roosevelt & Company is a fabulous meticulously researched historical account of the key players in the management of World War II. The footnotes are almost as long as the actual text carefully attributing important interesting information about the personal thinking of these individuals. It is apparent from reading Lewis LehrmanÃ¢â€šâ€œs analysis that Stalin certainly out maneuvered Roosevelt throughout the war. Churchill is seen once again as an indefatigable leader willing to do whatever was necessary to save both Great Britain and its allies. As in any human endeavor many of the individuals profiled in Churchill, Roosevelt & Company involved in this epic battle for the survival of democratic governments had outsized roles. Harry Hopkins appears life sized in the pages as does Averell Harriman, Joseph Kennedy and the US generals Marshall and Eisenhower. What really transpired at Yalta and Tehran as well as Dumbarton Oaks is vividly portrayed and the roles of lesser known players such as Harry Dexter White are described in detail. This is an academic history book that reads like a bestseller!

I've read so many books about Churchill, Roosevelt and World War 2 that I find myself questioning myself: Do I really need to read another? In this case a definite YES! I've learned so much more about

Roosevelt by reading it. This book lets us see him as a real, human, American politician instead of the god-like myth that is so often publicly portrayed.
