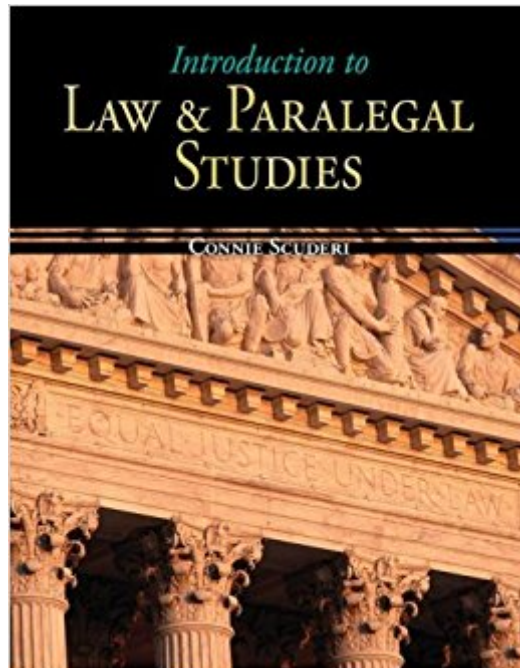

This text book is very vague. As a paralegal student I have a difficult time understanding what the objective of the assignments listed are because the directions are generally statements rather than instructions. Also, the book continually emphasizes the need for exceptional proofreading and editing skills in the legal environment--however, the book is filled with bad editing and proofreading. The first chapter exercises are actually from chapter 2 and the glossary has several editing mistakes. The book is only a starting point--I had to purchase several other books in order to actually understand what was being taught and how it applies to legal issues; if it was not the required textbook for my class I would have returned it for a refund.

There are so many errors in the book it is ridiculous. Errors are throughout the text, crosswords and review questions. My instructor contacted McGraw Hill to inform them of all of the issues and they refused to do anything to compensate the students. Do not buy this book!!! Even the material in the book is subpar.
